The past 18 months have been a period of change and growth for Heartly House. Not only have we had to manage the global economic downturn, state, federal and county budget cuts, and a lingering recession that has understandably caused those who have been generous in their support of the organization in the past to reconsider their charitable giving; but we have been challenged by the departure of the organization's Chief Executive Officer and the Development Director two key positions within the agency.

Thanks to the outstanding leadership of past-Chair, Julie Donat, and the commitment and devotion of an incredible staff of compassionate, caring employees, I am happy to report that Heartly House continues to be a State leader in Domestic Violence education, intervention and victim recovery. Our new Chief Executive Officer, Ashley Mancinelli, and new Development Manager, Robin Rose, are working hard to raise awareness about domestic violence and enhance our fundraising efforts. In closing, allow me to thank you for your support of Heartly House and to encourage you to keep us in your thoughts throughout the year. As financial support at all levels of the government is cleaved by the budget axe, the generosity of the citizens of Frederick County will be more important then ever before. Without question, someone you know is trapped in the despair and desperation that is domestic violence. Help us help them.

### **OUR SERVICES**

### HOTLINE

24-hour crisis line available for support and access to services.

### **EMERGENCY SHELTER**

Temporary, emergency shelter and emotional support to survivors and their children who need refuge from violence in their home due to domestic violence and sexual assault.

### TRANSITIONAL HOUSING

Short-term housing opportunities for up to two years for survivors and children leaving abusive situations who are working toward permanent housing.

### LEGAL

Staff attorneys provide consultation and representation for clients. Information, court accompaniment, and advocacy is provided by trained victim advocates.

### COUNSELING

Individual and group counseling is available to victims of abuse and their family. Day and evening appointments available.

### **ABUSER INTERVENTION PROGRAM**

Educational groups offer help for adults who want to end violence/ abuse toward their partners.

### MEDICAL ACCOMPANIMENT

Trained advocates accompany rape survivors through the SAFE (Sexual Assault Forensic Exam) process, providing support and advocacy.

#### COMMUNITY EDUCATION AND OUTREACH

Presentations on the topics of domestic violence, dating violence, healthy relationships, sexual assault, and sexual abuse are available to the Frederick community.

Heartly House services are available to all residents of Frederick County.

Heartly House, Inc. is committed to the effort of achieving a society free of violence by providing community education, working for the equality and empowerment of all, and developing and maintaining comprehensive services to survivors of domestic violence, rape, sexual assault, and child abuse.




