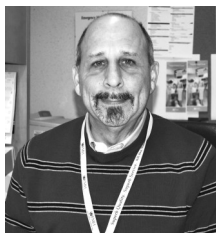

OUR SERVICES

HOTLINE

24-hour crisis line available for support and access to services.

EMERGENCY SHELTER

Temporary, emergency shelter and emotional support to survivors and their children who need refuge from violence in their home due to domestic violence and sexual assault.

TRANSITIONAL HOUSING

Short-term housing opportunities for up to two years for survivors and children leaving abusive situations who are working toward permanent housing.

LEGAL

Staff attorneys provide consultation and representation for clients. Information, court accompaniment, and advocacy is provided by trained victim advocates.

COUNSELING

Individual and group counseling is available to victims of abuse and their family. Day and evening appointments available.

ABUSER INTERVENTION PROGRAM

Educational groups offer help for adults who want to end violence/abuse toward their partners.

MEDICAL ACCOMPANIMENT

Trained advocates accompany sexual assault survivors through the SAFE (Sexual Assault Forensic Exam) process, providing support and advocacy.

COMMUNITY EDUCATION AND OUTREACH

Presentations on the topics of domestic violence, dating violence, healthy relationships, sexual assault, and sexual abuse are available to the Frederick community.

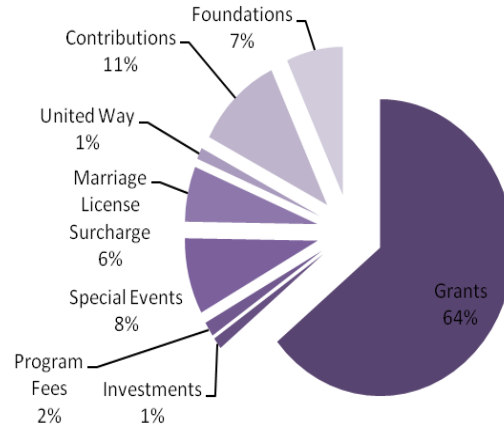

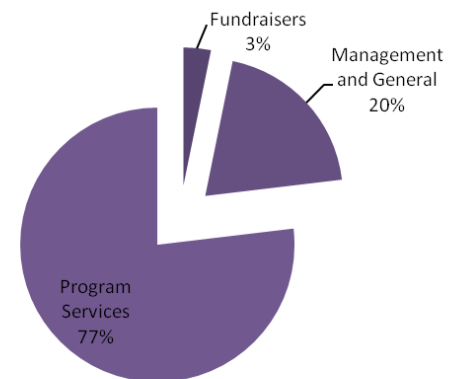
