A LETTER TO YOU

Dear Friends,

What an exciting time for Hearty House! This year brought new programs, new partnerships, and a new look to our work with victims of domestic violence and sexual abuse.

Thanks to a grant from the Meyer Foundation, we engaged ArachnidWorks, a local marketing firm, to develop a new logo, brochures, educational materials and a beautiful new website. We unveiled these new materials in April 2016 and hope that they convey our caring for our clients and our community.

Partnering with a yoga studio in Frederick, we began a trauma-sensitive yoga program for clients suffering from trauma symptoms. It proved to be a very popular program, and our clients were so grateful that we were able to respond to their special needs.

In response to the Federal Title IX law, we signed memoranda of agreement with Mt. Saint Mary's College, Hood College, and Frederick Community College. Title IX mandates that institutions of higher learning provide a systematic process to address claims of sexual assault on campus. Our partnerships with these local colleges have opened the door for us to work more closely with students and faculty residing in Frederick County.

Our Counseling Department had the good fortune to partner with Dr. Andrea Geilen, Johns Hopkins University, to conduct a pilot study that examined the Stages of Change Theory within a trauma-informed counseling practice for intimate partner violence survivors. The results of the study, which indicate that the model can work with survivors, were displayed in a poster session at the National Conference on Health and Domestic Violence Conference.

Finally, the Hearty House Crisis Services Director, along with the Director of Forensic Nursing at Frederick Memorial Hospital and a detective from the Frederick Police Department, attended a four-day training on strangulation at the Institute for Strangulation Prevention in San Diego, California. Knowing more about strangulation, its impacts and damage, is critical for helping our clients to stay safe.

While Hearty House continues to provide the legal, counseling, crisis intervention and shelter services for which we are known, we never stop learning or growing or reaching out to others to continue to provide the most informed, compassionate and comprehensive services possible to our community.

We are so grateful to you for your ongoing support of Hearty House. We are privileged to have such a wonderful group of supporters who share our mission of safety for all.

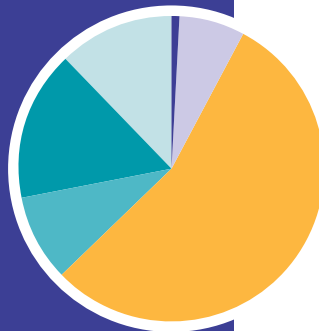
