

The mission of Heartly House is to end domestic violence, sexual assault. human trafficking, and child abuse, and to provide victims with safety, shelter, and supportive services.

What is Intimate Partner Violence (IPV)?

The CDC defines IPV as a serious, preventable public health problem that affects millions of Americans. The term "intimate partner violence" describes physical violence, sexual violence, stalking, and/or psychological harm by a current or former partner or spouse.

At Heartly House, we understand that each client's experience is different, and so we are here to listen, understand, support, and encourage-without judgement.

Through our trauma-informed service model, staff provide education, supportive services, and referrals to community resources and empower victims to make the best choices for themselves. The goal of all of our services is to increase safety and wellbeing.

A continuum of care is critical for victims of domestic and sexual violence. and that is what Heartly House is all about. Trauma may begin with a single incident or it could be a series of behaviors, interactions, and exchanges over time. Each victim deals with that trauma in their own time and in their own way-there is no statute of limitations on addressing and recovering from trauma.

Intimate partner violence, sexual assault, human trafficking, and child abuse result in unique trauma that often is unseen and under-reported, leaving victims feeling powerless, hopeless, and alone.



While this report is meant to reflect on the impact and accomplishments of the last fiscal year, we remain in that perilous 'in between' space with COVID-19 still threatening our public health in so many ways.

There was no interruption in Heartly House shelter, hotline, counseling, or legal services; however, while stay at home orders were put in place to flatten the curve of COVID-19, victims of every age and gender struggled to reach out for help and resources while guarantined with their abusers. There are increases in demand for Heartly House services across the board, and a terribly disturbing increase in the severity of violence and use of weapons.

Community Engagement **& Prevention**

The first step in prevention is education and community engagement, and we are making great strides.

65 Programs & Trainings reached nearly 1,600 people across Frederick County, including:

virtual platforms as we adjusted to COVID-19 restrictions and included an inaugural event focused on male survivors of childhood sexual abuse.


Community Awareness Promoting

Empowerment for Male Survivors (CAPES) was the first virtual panel discussion on male survivors of childhood sexual abuse, and included survivors, spouses, parents, and mental health professionals and drew more than 80 participants.

24-Hour Hotline & **Crisis Support**

The hotline is often the point of entry for clients. Highly trained call specialists listen, support, and provide essential resources to victims and survivors throughout their healing journey.

- Over 1,700 follow-up calls to victims to ensure they connect with services, answer additional questions, and provide support.
- 896 lethality screenings-643 screens (72% of all screen completed) showed the client at extreme risk for serious injury or death by an intimate partner.
- 78 victims of sexual assault and domestic violence received support from medical accompaniment staff while in the Emergency Department for a recent incident of assault.
- 79 individual crisis intervention sessions

Emergency Shelter & Service Coordination

- 45 adults and 26 children (71 people) who were in immediate physical danger found safety in our emergency shelter for a total of 3,015 bed nights (25% increase over previous year).
- 76% shelter clients at the end of their stay reported no incidents of verbal abuse.
 - Clients that have children in common with their abusive partners usually must remain in at least verbal contact with them. It is not surprising for verbal abuse to continue or even increase if the abusive partner no longer has physical access to the victim but there is verbal contact regarding the children.
- 96% of shelter clients at the end of their stay reported no incidents of physical abuse.
- 100% of shelter clients met at least one basic need by the end of their shelter stay.
- 83% of shelter clients met all their basic needs by the end of their shelter stay.

Legal Advocacy & Representation



clients received Legal Advocacy

- 194 of those clients had Legal Advocacy accompaniments
- 283 Peace Order accompaniments
- 50 Criminal accompaniments
- 15 Family Law accompaniments
- 29 Prosecution interviews
- 8 Law Enforcement interviews
- Clients were represented by Attorneys in Peace/Protective Order Hearings. Attorneys appeared in court 468 times on behalf of clients.
- Attorneys supported 27 clients in family court and represented them 48 times for Family Law matters.

Data shows that not all Legal Advocacy clients go to court. Attorneys representing clients can go to court multiple times for the same client.

Counseling

2,716

individual counseling sessions and 212 group sessions were provided by the clinical counseling team and interns, a more than 22% increase from the previous year.

Of Clients Surveyed:

- 98% of clients who had experienced intimate partner violence agreed or strongly agree that they feel more knowledgeable about how to plan for their safety.
- 100% of clients who had experienced sexual assault agree or strongly agree that they have a better understanding of the symptoms related to trauma.
- 90% of clients agree or strongly agree that they are not responsible for the assault they experienced.
- 100% of child/teen clients agree or strongly agree that they are learning how trauma can affect their thoughts, feelings, and behaviors.
- 90% of child/teen clients agree or strongly agree that they are not responsible for the abuse or assault they witnessed or experienced.

Abuse Intervention Program (AIP)

The Abuse Intervention Program aims to increase the safety of victims of intimate partner violence by holding abusers accountable and teaching healthy relationship skills.

Those accepted into the program are required to attend a weekly 90-minute group session for a total of 26 weeks. Groups for men are cofacilitated by a male/female team.

Traffickers use force, fraud, or coercion to lure their victims and force them into commercial sexual exploitation.







In May, a family of three exited after an extended 61-day shelter stay. The client is a past victim of trafficking and a current victim of IPV. While in shelter, she maintained full-time employment, found and worked a second full-time job, and engaged in Heartly House counseling services. She saved money and had costly repair work completed on her vehicle. The client, in collaboration with our Service Coordinator, created a budget and was approved for a local apartment. Through a local grant, Heartly House was able to provide first month's rental assistance.

In her exit interview about the shelter stay, this client wrote, "I feel stronger...as though I can make anything happen now. My kids are a lot happier and life is turning around for us. You all gave the support needed to uplift me and keep me going."
