Letter from the **President & Executive Director**

DEAR FRIENDS,

Our work at Heartly House could not be done without the allies and community partners who support our mission and services.

As you will see from this report, three years of COVID changed Heartly House and our clients. We have come out of the pandemic stronger than we have ever been, financially, programmatically, and reputationally, largely due to the incredible partners we work with in our magnificent County.

The increase in clients served between 2019 and 2023 was an unprecedented 49%. In addition, nearly 90% of all victims of intimate partner violence in Frederick County were assessed at high risk for bodily injury or death. Heartly House staff saw some of the most brutal cases we have ever experienced and there seemed to be no respite. The heavier and more severe caseloads were difficult on staff who suffered burn-out and vicarious trauma. Heartly House needed to step up our staff capacity and self-care efforts to protect staff and clients.

On the other hand, the last several years also brought us enhanced and expanded programming. We launched our Community-Based Services Department, which now has five satellite offices and three case managers. We began our Child Sex Trafficking program, which this year expanded to serve survivors of Labor Trafficking as well as adult victims. Our Abuse Intervention Program received funding last year to begin a Spanish-speaking group.

Our programmatic growth has necessitated that we also shore up our administrative infrastructure. To that end, we have created a position to help us track our grant spending more closely and one to handle the day-to-day tasks of the Development Department. We even have an IT Department, with two employees.

We believe wholeheartedly that we can end intimate partner violence, sexual assault, human trafficking, and child abuse. We also know we cannot do it alone. The partnerships we've created with law enforcement, social service organizations, behavioral health professionals, and the justice community in Frederick County will help us prevent these crimes and create a thriving community where power-based violence has been eliminated.

This annual report celebrates Heartly House's progression from the onset of COVID-19 in 2020 to the post COVID-19 period and beyond. We recognize that the pursuit of a less violent society is a collective effort, and we would not be where we are today without your support. Thank you to our funders, donors, staff, volunteers, allies, and community partners for supporting our critical efforts to end power-based violence. Together we will thrive.

Fiscal Year 2023 Impact

The COVID-19 Pandemic exacerbated an already critical social crisis. Intimate partner violence, and sexual violence grew more violent and more frequent, and as we move past those initial pandemic years, those trends are not declining. The need for Heartly House's services is greater than ever and growing. Over this past year:






