FISCAL IMPACT 2024

In the past year, Hearty House continued to serve as a lifeline for individuals facing intimate partner violence, sexual assault, human trafficking, and child abuse.

Across all departments—crisis, legal, case management, counseling, residential, and community engagement—our dedicated teams served over 1,700 individuals. Each of these individuals represents a life touched by your generosity and the care of our staff, moving from crisis to safety, from trauma to healing.

To put that in perspective, if 1,700 people stood shoulder to shoulder in a line, they would stretch for about the length of 16 football fields.

While the ripple effects of our work may go unseen and unreported, we know that our efforts contribute to better lives for those we serve, their families, and our entire community.

COMMUNITY BASED SERVICES

Heartly House staff works tirelessly alongside human service providers, businesses, government agencies, and other community partners to ensure that our clients are connected to the essential services and support they need.

In FY24, we experienced a 211 percent increase in service coordination, demonstrating our commitment to making a difference. This resulted in 2,592 contacts being made on behalf of our clients, reflecting our dedication to providing comprehensive and compassionate care.

HUMAN TRAFFICKING

The Community Based Service Team has recently expanded to better meet the needs of our community.

The growth includes the addition of Case Managers. Our Director of Community-Based Services co-chairs the Frederick County Human Trafficking Response Team (HTRT).

Our Community-Based Services department provides comprehensive support to human trafficking survivors of all ages, with specialized services for individuals up to age 24. We offer case management that connects clients to essential resources such as food, housing, healthcare, and more. Additionally, our case managers provide ongoing emotional support and assistance in achieving personal goals.

Our team plays a crucial role in conducting screening assessments and linking youth to vital services and resources, including food, housing, healthcare, basic living needs, counseling, substance abuse treatment, and legal services. This program also offers continuous case management and support tailored to each client’s needs.

COUNSELING SERVICES

Free and confidential, our counseling is delivered by trauma-informed, licensed clinicians who are dedicated to helping survivors navigate their recovery journey.

These clinicians are specially trained to understand the complexities of trauma and its impact on both the mind and body. Whether through one-on-one sessions or group settings, our counselors work collaboratively with survivors to develop personalized strategies that promote healing, resilience, and empowerment.

By addressing the emotional and psychological effects of trauma, Heartly House aims to help survivors rebuild their lives with strength and confidence, knowing they are not alone on their path to recovery.



It is a pervasive issue that knows no boundaries, impacting individuals and communities on a large scale.

At Heartly House, we are committed to addressing this complex problem holistically. By building a strategic network across Frederick County, we are creating a united front to combat power-based violence in all its forms. Our approach involves not only providing immediate support to those affected but also working to prevent future violence through education, advocacy, and community engagement.

We understand that the ripple effects of our efforts extend beyond the individuals we serve; they reach into the very fabric of our community. As we strengthen our partnerships and expand our services, we are laying the foundation for a safer, healthier, and more resilient Frederick County. Together, we are fostering an environment where survivors can heal, families can grow stronger, and our entire community can thrive.

EDUCATIONAL TRAININGS AND EVENTS

To further its mission, Heartly House offers free educational training and events to Frederick County businesses, schools, and community groups. These programs equip participants with the tools to challenge harmful behaviors, support survivors, and foster a culture of respect and safety. In 2024, we focused on educating youth about interpersonal violence, strengthening partnerships with local colleges, and expanding outreach in Frederick County Public Schools. A grant from the Maryland Community Health Resources Commission enabled us to hire three staff members to lead in-class workshops, peer groups, and training for faculty, parents, and caregivers. Our goal is to equip the next generation with the knowledge and tools for safe, respectful relationships while connecting families to Heartly House's continuum of care.


